The DZ BANK Group at a glance

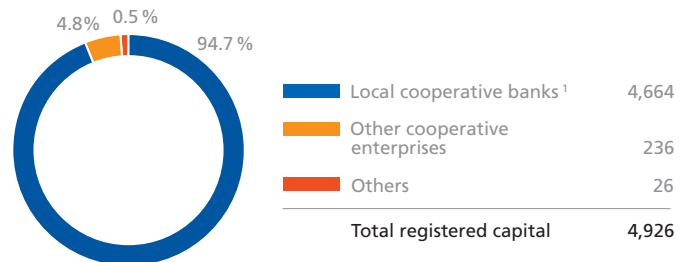

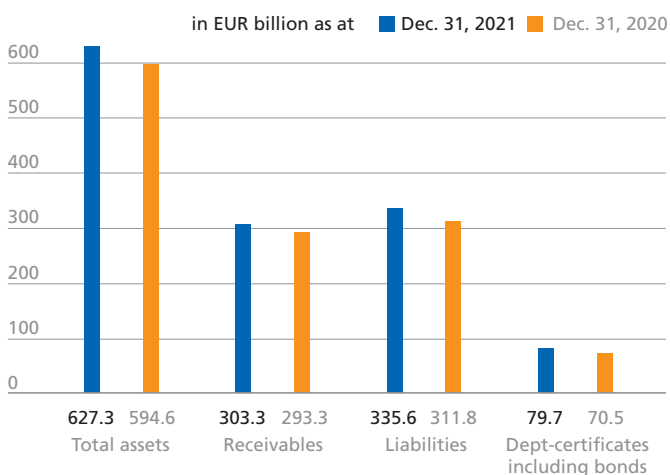
